- 1. A non-refundable booking fee of \$100 of the above fee is payable with this contract. The balance of \$400 will be paid upon the mare's arrival or before the AI shipment is to be sent out. Payment is to be made by check or money order unless other arrangements are made in advance.
- 2. A Mare Care payment of \$15.00 per day will be charged for each full or partial day that the mare is under the care of Wild Mountain Farms, if you are doing Live Cover and sending your mare here to breed.
- 3. **For AI Clients:** An additional \$50 fee will be charged per shipment if the mare needs more than 2 shipments to get pregnant.

#### **HEALTH DETAILS – for live cover mares**

- 4. A copy of the Mare's registration and health certificate must accompany the mare upon delivery to WMF. These must include:
  - a. A recent culture to be taken from the mare prior to arrival, certifying that she is free from disease or infection.
  - b. Up-to-date vaccinations and worming.
- 5. Mare must have hind shoes removed prior to arrival.

#### LEGAL DETAILS

- 6. WMF agrees to diligently try and settle the above named mare and shall have sole discretion of determining the best method of breeding this mare. If, however, the mare does not settle, WMF shall be held harmless. (As per standard in the breeding industry, there will be no refund of the stud fee under any circumstances.)
- 7. Should the above named stallion die or become unfit for service before breeding the mare, the stud fee or portion thereof paid by the Mare Owner, less expenses owed by the Mare Owner, will be refunded by WMF, thereby canceling this contract. No refund will be made by WMF should the stallion die or become unfit for service after the end of the breeding season. In this case, the mare owner may rebreed the above named mare during the following season to another available stallion on the farm. (As per standard in the breeding industry, there will be no refund of the stud fee under any circumstances.)
- 8. If the above named mare dies or becomes unfit to breed before the mare has a Live Foal, the Mare Owner may substitute another mare with the agreement of WMF. (As per standard in the breeding industry, there will be no refund of the stud fee under any circumstances.)

#### LIVE FOAL GUARANTEE

If the mare does not conceive, looses the baby before birth, or the baby does not live long enough to stand and nurse, the mare owner may bring the mare or a different mare back to be rebred that same season or the next season, without incurring an additional Stud Fee. This clause only applies if we still own and are standing a stallion. However, there will NOT be any refunds of stud fees.

#### FINANCIAL DETAILS

- 10. All additional expenses (see attached Schedule of Fees) incurred by the Mare while at WMF will be due upon receipt of the bill from WMF
- 11. A finance charge of \$20 will be added for every 30 days that the balance remains past due.
- 12. A breeder's certificate will be issued to Mare Owner after all expenses have been paid in full and notification of the foal's birth.

#### WAIVER OF LIABILITY

13. Both parties agree that WMF, its owners, employees, contractors, veterinarians and guests shall not be liable for any injury, escape, disability or death of the above named mare or any accompanying foal. Further, neither Mare Owner nor anyone else connected to the above named mare or Mare Owner shall be liable for any injury, disability or death of any person or animal caused by the mare while she is at WMF.

PLEASE NOTE: Occasionally we get a mare in who does not show heat to our stallions. In such cases, we cannot identify the appropriate breeding time and thus, cannot breed the mare. If such a problem is suspected prior to her arrival, or discovered during her stay here, we recommend that you authorize palpation or ultra sounding of the mare periodically throughout the cycle to identify appropriate breeding dates. If this is not authorized, then it is unlikely that we will be successful in breeding a mare who doesn't show.
